

# The Rev. Susan Masters, Interim Pastor Annual Report, 2022 (for 2021)

A couple days ago I wrote in a Facebook text, "I have been blessed to be in lockdown with a gorgeous congregation that has taken such good care of me in this dreadful time." And I meant it. Again and again, you have put aside your own needs for the good of the whole community. When you yearned to be back together in the sanctuary, you patiently waited until it was deemed safe. When we recently needed to tighten up our safety measures again, you cooperated. Friends, it is precisely this sort of selfless care for others that will ultimately get us through this very difficult time and help us find our way again in ministry and mission for the sake of the world.

And to be clear, we have not been sitting on our hands this past year. Although the interim/ transition train has been slowed way down, it has continued to roll down the track on behalf of Gustavus Adolphus Lutheran Church:

- We moved to hybrid worship (both in-person and on Zoom) in June.
- We have continued to reach out to our children through activity mailings and Sunday morning story time.
- Our council and committees have continued to meet and conduct the business of this congregation.
- Our transition team continued its work, with congregation-wide conversations this past summer about mission, money, and conflict.
- Deacon Phil Holzman has seized every safe opportunity to expand music bringing back the sanctuary choir, handbell choir, and ensemble whenever possible.
- The quilters group, Wednesday morning coffee hour, and men's breakfast have continued to safely meet and offer social connection to folks.
- We've had several baptisms this year, and this fall we were finally able to begin holding funerals again.
- Open Door language school has begun holding classes again.
- I have no doubt there are other things I'm not remembering ....

So, while maybe this isn't the robust report you're accustomed to, it IS the report of a faithful community of faith that has endured much, weathered greatly, and held fast to their love of God and one another. It hasn't been perfect (turns out we're a group of flawed humans ...), but it has been full of heart and kindness. I'll take that over perfection any day.

Finally, about your call process: We are ready to get it started. And, as you will hear about later in this meeting, we have an opportunity to discuss exploring deeper partnership with Mt. Carmel Lutheran Church - also currently in interim – in ways that will expand mission for both congregations. It seems wise to take the time to see how such conversations might inform our call process. Stay tuned!

As always, I am truly blessed and humbled to be mixed up with the lot of you in this ridiculous time. Thank you for your kindness, your partnership, and all that you have taught me in the past 2 ½ years. I am a better person for having walked this time with you. And I love each one of you so much.

The figures above represent our income/expenses through December 30, 2021.

Dec 2021 YTD Actual Income of \$315,609 represents 97% of our budgeted \$325,079.

Dec 2021 YTD Expenses of \$325,079 represent 97% of our budgeted \$325,079.

The (\$825) difference constitutes our YTD deficit.

As compared to last year, YTD our income is up \$7,101 while expenses are down (\$4,975).

\*Note: We recognized \$41,925 of income on our 2020 PPP Loan in Aug of 2021.

Funds were used to pay 2020 expenses; income was not recognized until 2021 when the loan was forgiven.

The "Adj Inc-Exp" of \$21,413 reflects this adjustment.

#### We are so grateful for your faithful support to help us close out 2021 with an extremely small deficit!

I would also like to take this opportunity to thank Gary Anderson and Andrea Carter for their faithfulness to count our church offering bi-weekly throughout 2021 as well as their continued service on GA's Finance Committee. We are also grateful for the many years of service from Larry Knoebel and miss his presence in our monthly meetings.

As we transition into 2022, please consider how you might continue to faithfully support our ministry growth here at GA.

#### **Deacon's Report for 2021**

2021...What can we say about 2021? Year two of a global pandemic that has continue to throw all our lives – and the life of our congregation – into upheaval. My goodness, it's been challenging!

Let me start by reminding you how my year started on a personal level. It started with a bang ... literally ... on January 18, 2021, as I observed the MLK holiday with my daughter and granddaughter by going ice skating. I took a nasty fall and broke both my left arm and left wrist – requiring surgery and rehab on both. I was away from the organ and piano until mid-March, but only away from my church computer for a day or so! My wrist healed well, but it's been a long year with my injured arm; I'm due to have surgery on it again on January 25 (rescheduled to February 25) of this year to hopefully correct the "frozen shoulder" that has set in and limited my movement.

Enough about that. Church life continued through the pandemic as best that we could. Last January we held our annual congregational meeting virtually (on Zoom) – a first, but we did it! For the first part of the year, I was working mostly remotely/from my home office, coming into the church usually one day a week – on Wednesdays. People soon got to know that Wednesday was my "church day" and would stop by to say hello or conduct some business with me while I was in the office. By mid-March, I was back playing for worship again as we looked toward another Holy Week and Easter of worshiping online with an empty sanctuary. We ordered palm branches and had people pick them up at the church to wave at home on Palm Sunday and did have a Prayer Vigil at the church, which got some people into the building for a bit. April brought Holy Week and Easter, with a full complement of worship services. I hired a trumpet player to spice up the music for Easter a bit. (I figured a full brass quartet was a bit of overkill for an empty sanctuary!)

We planned an outdoor worship service for Pentecost Sunday in May, but those plans were thwarted by a forecast of rain that threatened to ruin the thousands of dollars' worth of electronic equipment we had rented for the occasion. We did eventually hold three "Holden Evening Prayer" services outdoors over the summer, attended by a cadre of folks who love that liturgy.

In June we began the return to in-person worship...slowly. We've been having hybrid worship ever since, with some of our folks attending in person and many still worshiping on Zoom each Sunday. This pandemic has surely forced us to learn new ways of doing things. We had to make the difficult decision to cancel our summer children's musical for the second year in a row, due to safety concerns. I have been able to connect with a small group of our kids on Zoom and sing with them several times throughout the year – I call it "Virtual Choristers." It's not the same as meeting in person, but it's a connection nonetheless. By summer, I was also working more in the office, usually two days a week, while continuing to work two days a week at home. Thank goodness for technology which allows this kind of schedule to work.

I meet with two church committees on a regular basis: the Property Committee and the Congregational Life Committee. You will find reports from those committees elsewhere in this booklet, so I won't expound on what they have done this year, other than to thank the members of those groups for their service this year. I also meet monthly with the Church Council, who has done a marvelous job of helping us navigate through these pandemic waters this year. I have met with a few *ad hoc* committees as well, including a group charged with keeping us safe as we gather in the building and a group meeting with members of Mt. Carmel Church.

In fall, the Senior Choir and Gustavus Bells began meeting for rehearsals after not getting together since March of 2020. It was good to be back together, though not everyone chose to return for safety concerns. These groups provided music on several Sundays through the fall up until Christmas Eve. They're on a bit of a winter hiatus right now, but we're hopeful that they can resume for Lent and Easter – if it's safe to do so.

Yes, this year has been challenging. You don't need me to tell you that. But I'm also extremely grateful:

- I'm grateful that our church is still here preaching, telling, and singing the Good News of Jesus Christ to a weary world every Sunday morning.
- I'm grateful to everyone who has faithfully supported this church financially throughout the pandemic and allowed us to keep going.
- I'm grateful to everyone who has been so kind to me all year long when I was injured and throughout the year with their kind and encouraging words.
- I'm grateful to those who help lead worship: our song leaders, assisting ministers, lectors, children's sermon leaders, greeters, and everyone who helps out on a Sunday morning.
- I'm grateful to our lay leaders those on Church Council and committees for the time and energy they devote to helping to further the ministry of our congregation.
- I'm grateful for my office and "Gazette" volunteers.
- I'm grateful to Joel Lurvey for his great musical companionship on staff.
- I'm grateful to Linda Lindahl and Zachary Copa for their roles on our staff in 2021.
- And I'm especially grateful to Pastor Susan Masters, my pastoral colleague, for her wonderful companionship as we have navigated these strange waters of the pandemic together. I can't imagine doing this without her partnership!

Blessings to each one of you as we enter the year 2022. May you be healthy and safe as you live out your calling as a Child of God!

Our annual congregational meeting took place on Sunday, January 30, with some members attending in the sanctuary and some members attending online via Zoom. Church Council president Matthew Streed presided over the meeting where the following actions were taken by the congregation:

- Dee Kjera was re-elected to a second two-year term on the Church Council.
- The 2022 operating budget was unanimously approved.
- \* After a presentation by Pastor Susan Masters and Jenny Parker, the congregation approved moving forward/continuing conversations with Mt. Carmel Church as we explore possibilities of shared ministries and staffing with a report due back from the task force to the congregation after Easter. Representing GA on the task force so far have been Pastor Susan, Jenny Parker, Deacon Phil Holzman, Matthew Streed, and Wendy Bradshaw. Two additional members will be recruited going forward.

James Hamilton was thanked for his service on Church Council. (There were no nominations from the floor to fill James' spot on the council, so the council has the discretion to appoint someone to fill the slot.) Pastor Susan gave her report, which included an update on the interim/call process.
